HANDLING AND STORAGE

TERMIX[®] 5484 surfactant may be satisfactorily stored in stainless steel tanks using steel pipes and pumps.

For longer term color stability, it is recommended that the product be stored under an inert atmosphere.

Low pressure steam coils in storage tanks and steam tracing of transfer lines should be provided in cases where low environmental temperatures may make pumping of the product difficult.

BIODEGRADABILITY AND ENVIRONMENTAL SAFETY

Although Huntsman Corporation has not conducted biodegradability studies on the TERMIX[®]-series products, constituents of these products are widely recognized as being readily biodegradable in the environment.

Numerous studies conducted by other workers¹⁻⁴ show that linear alcohol ethoxylates and nonylphenol ethoxylates rapidly undergo ultimate biodegradation to a significant degree (>90%) under a wide variety of conditions, including those present in secondary wastewater treatment plants and in river die-away tests corresponding to all seasonal conditions.
