# PARALOID™ B-84 Thermoplastic Solution Resin (45%) For Refinishing Glass-Fiber-Reinforced Plastics, Tie Coats, and Touchup Enamels

### Introduction

PARALOID™ B-84 Thermoplastic Solution Resin (45%) has the unique characteristic of air-dry adhesion to thermoset substrates. It can be used for coatings which will adhere to problem surfaces such as glass-fiber-reinforced polyesters, thermosetting acrylic, polyester and alkyd finishes, and various plastic substrates. PARALOID™ B-84 Thermoplastic Solution Resin (45%) is well suited for refinishing glass-fiber-reinforced plastics and other plastic surfaces, tie coats for refinishing, and touchup enamels for appliances.

PARALOID™ B-84 Thermoplastic Solution Resin is supplied at 45% solids in toluene/sec-butanol at a solvent ratio of 85/15.
