Product properties

Polyglykol B o1/80 is a clear neutral, viscous liquid at room temperature. Polyglykol B o1/80 is insoluble in water, but soluble in many polar organic solvents like acetone or methanol. Polyglykol B o1/80 can be dispersed much better in pure hydrocarbon solvents than the more hydrophilic B 11-type polyglycols. Polyglykol B o1/80 displays a very low solidification point of
