The durability and non-yellowing characteristics of PARALOID™ B-72 Thermoplastic Solution Resin (50%) make it valuable for use in pigmented coatings as PARALOID™ B-72 Thermoplastic Solution Resin (50%) has low reactivity with sensitive phosphorescent and luminescent pigments. It also had wide utility in the graphic arts and aerosol coatings markets.

PARALOID™ B-72 Thermoplastic Solution Resin (50%) is compatible with other film-forming materials, such as vinyls, cellulose, chlorinated rubbers, and silicones. It can be used in combination with them to produce coatings with a wide variety of characteristics.

PARALOID™ B-72 Thermoplastic Solution Resin is supplied at 50% solids in Toluene. A solid grade is also available.
