

Applications Hostavin 3053 liq. can be used in solventless and solventborne paints. Depending on the requested stabilization, the addition rate should be in the range of 1.0 to 3.0 %. All concentrations relate to active UV stabilizer on solid resin. As a non-substituted HALS, Hostavin 3053 liq. is slightly basic and can have an influence on the crosslinking of binders. In such a case, the alternative use of Hostavin 3058 liq. is recommended.

Storage stability Minimum shelf life is 3 years from the date of shipping when properly stored. Store in a cool and dry place.
