## **INCORPORATION**

FH-988L can be added directly in powder form. No need for polar activator or pre-gel. Recommended procedures are as follows:

- (1) Water.
- (2) FH-988L(Dispersing at high speed shear for 15-30minutes).
- (3) Other additives(film-forming agent, dispersing agent, defoaming agent, etc).
- (4) Pigment and filler (Mixing and dispersing).
- (5) Emulsion (Mixing).
