## HAZARDOUS INGREDIENT TOXICITY DATA

Hexanoic acid, 2-ethyl-, zinc salt, basic has oral (rat) and dermal (rabbit) LD50 values of >2000 mg/kg, respectively. Direct contact with this material may cause mild skin and moderate eye irritation. Suspected of damaging the unborn child demonstrated by weight loss/reduced weight gain and clinical signs of respiratory effects were observed (read across substance 2-ethylhexanoic acid).

The oral LD50 (rat) value of this UVCB was found to be > 2000mg/kg bw. Based on in vitro studies, the substance is irritating to eyes and to skin, but not corrosive. Animal studies have shown moderate allergic reactions upon dermal exposure. Based on in vitro studies genotox effects are not expected. After repeated dose exposure via de oral route (28 days), no adverse effects were seen up to the highest dose of 1000mg/kg on the parental animals. No developmental toxicity was observed and reproductive parameters were not affected. Carcinogenicity has not been investigated.
