RHOPLEX™ HG-1630 Emulsion is a vehicle designed specifically for use in the formulation of high gloss enamels. Enamels based on this product dry quickly, permitting recoat within 3 hours, have excellent gloss and application properties, along with excellent adhesion.

Although designed for use in pigmented interior gloss finishes, RHOPLEX™ HG-1630 Emulsion may also be used in interior clear coatings and on dimensionally stable exterior surfaces. RHOPLEX™ HG-1630 Emulsion based gloss enamels are also characterized by their:

- Excellent gloss and film clarity
- Excellent exterior gloss and tint retention
- Excellent flow and leveling
- Excellent adhesion to aged alkyds under either wet or dry conditions
- Good open time versus dry time balance
- Excellent early print and block resistance
- Early tack-free time (approx. 2 to 3 hours)

- Low odor
- Detergent resistance
- Spatter resistawnce
- Resistance to yellowing
